Wildfire Risk Reduction Grant Program Monitoring and Assessment Status Summary, January 2014

The Wildfire Risk Reduction Grant program (WRRG), created under Senate Bill 13-269 and passed by the 2013 Colorado General Assembly, is focused on projects that reduce the risk for damage to property, infrastructure, and water supplies, and those that limit the likelihood of wildfires spreading into populated areas. \$9.8 million in competitive grant funds will be directed to non-federal lands within Colorado to reduce the risk of wildfire in areas where human development and forested lands overlap, areas often called the wildland-urban interface.

The Colorado Forest Restoration Institute (CFRI) at Colorado State University was selected to carry out an effectiveness monitoring strategy for projects funded by the WRRG program. We are using objective, rigorous quantitative measures of hazard reduction to assess project effectiveness. Pre and post treatment field collected fuel measurements will be analyzed using the Fuel Characteristic Classification System, a peer reviewed fire behavior and effects model, which assigns a straightforward hazard rating across the landscape.

Following the first round of WRRG awards in August 2013, CFRI developed a monitoring sampling protocol to collect data on surface and tree canopy fuels. In fall 2013, CFRI completed fuels monitoring on approximately 1200 acres of WRRG funded projects across Colorado. Additional monitoring is ongoing and will continue on projects funded by the next round of grant awards in May 2014. CFRI will also be assessing equipment purchases made with grant funds, such as chippers and biomass boilers, and the effectiveness of those programs in accomplishing hazard fuels mitigation.

The Colorado Forest Restoration Institute was established in 2005 at Colorado State University to develop, compile, and apply locally-relevant scientific knowledge to achieve forest restoration and wildfire hazard reduction goals in Colorado and the Interior West. The role of CFRI in the WRRG program is to assess hazard reduction and learn from each project to ensure these and future wildfire hazard reduction funds are spent effectively. Technology transfer and workshops will be an integral part of our assessment program, with openness and sharing current scientific knowledge about hazard reduction and forest restoration remaining our core objective.


