



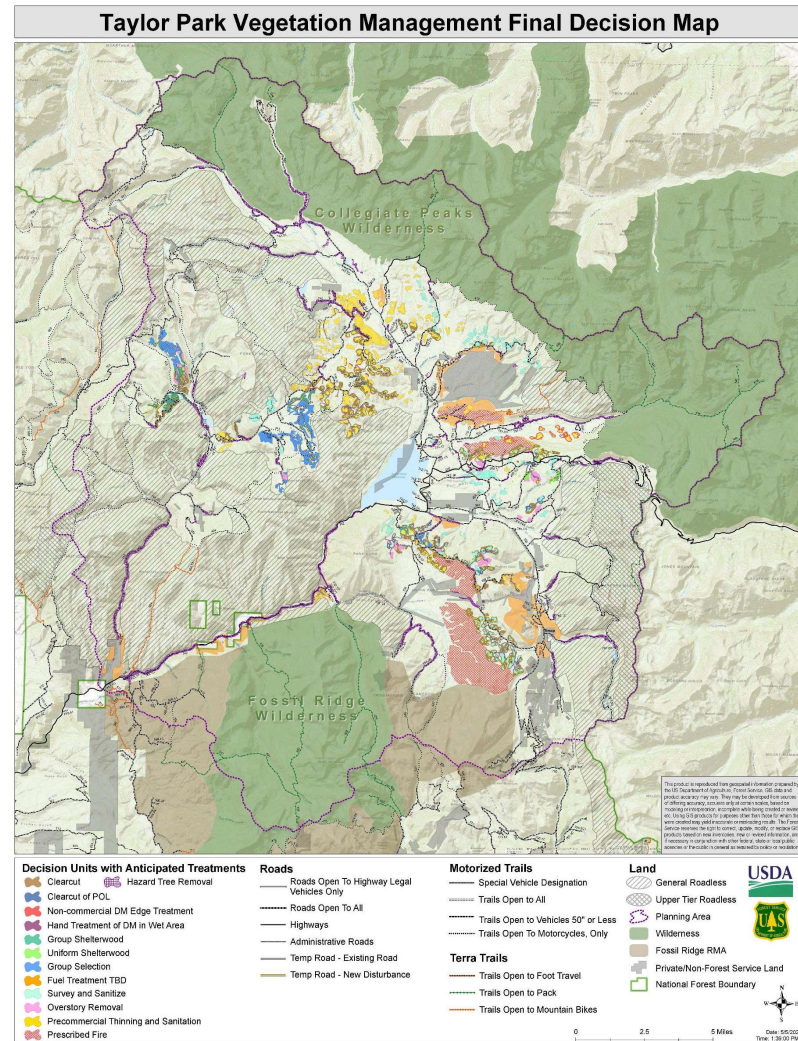

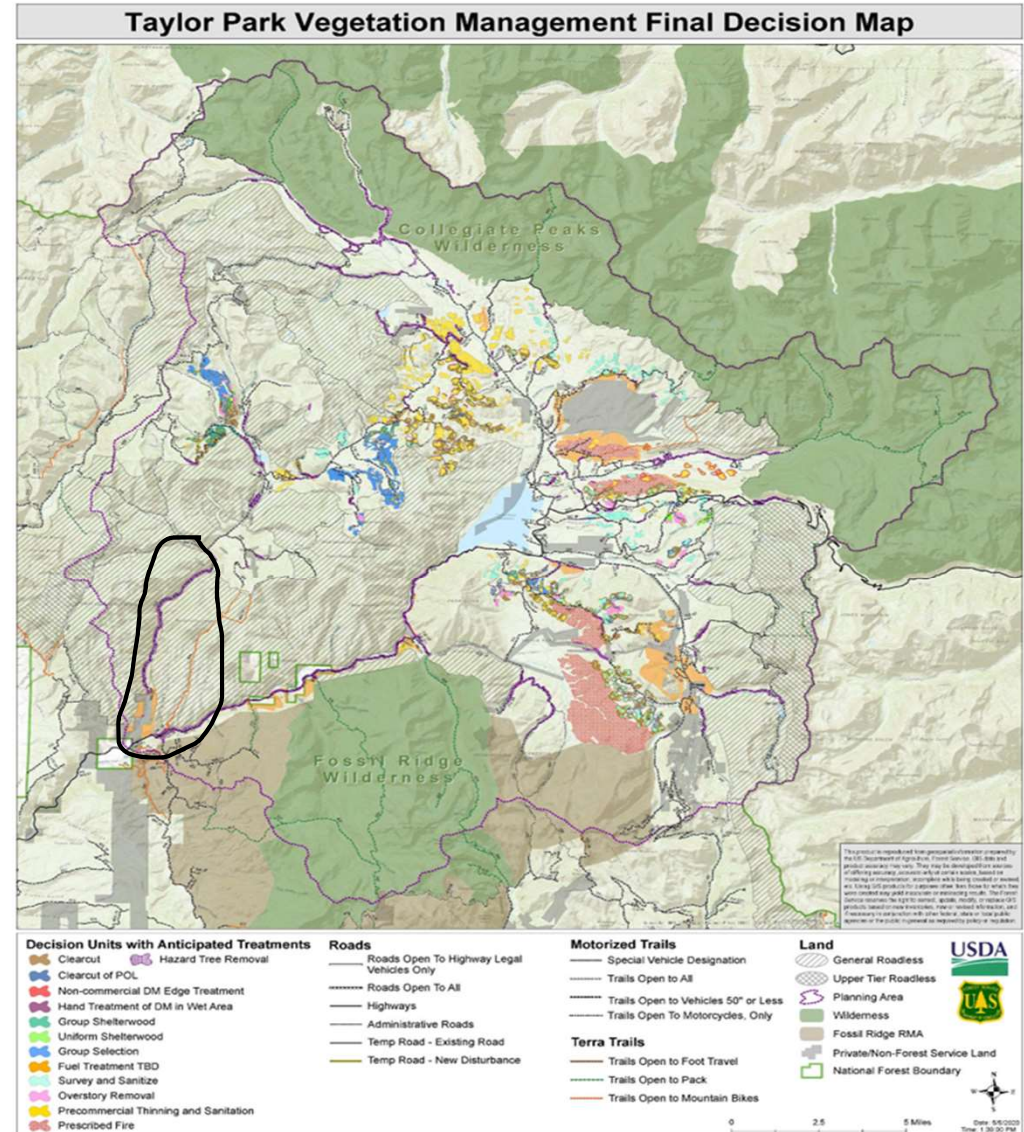
Roadside Hazard Tree Felling

Condition Class: Along main roads where dead, dying, or damaged trees are at risk of falling onto roadways. Main roads include the county roads, maintenance level 3 to 5 roads, and the more heavily used maintenance level 2 roads



Roadside Hazard Tree FY 2023

- NEPA – Taylor Park EA
- acres will depending on funding
- No temporary road construction or reconstruction
- Treatments include: 200' either side of the road
 - Hazard tree felling
 - Sight distance clearing
 - Pruning and ladder fuels treatment
 - Camp ground Hazard trees
 - Clearcut or patch cut in polygons
- Late summer and fall operating season
 - June – November
 - Termination date – Dec 31th, 2023
- Advertising in May 2023

- Thinning and piling 8 inch and below

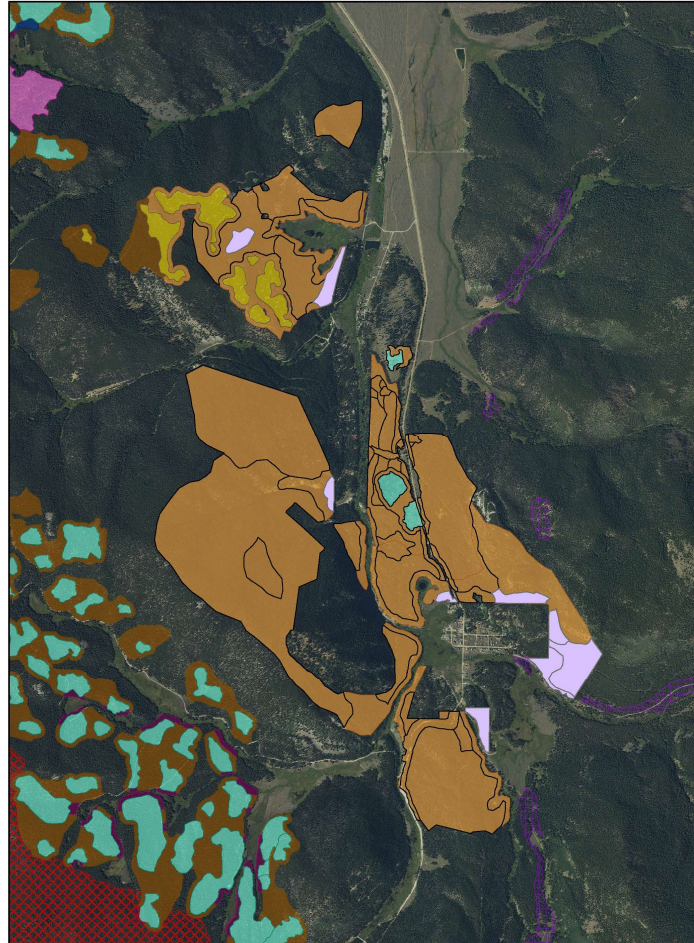
Late spring and summer operating season

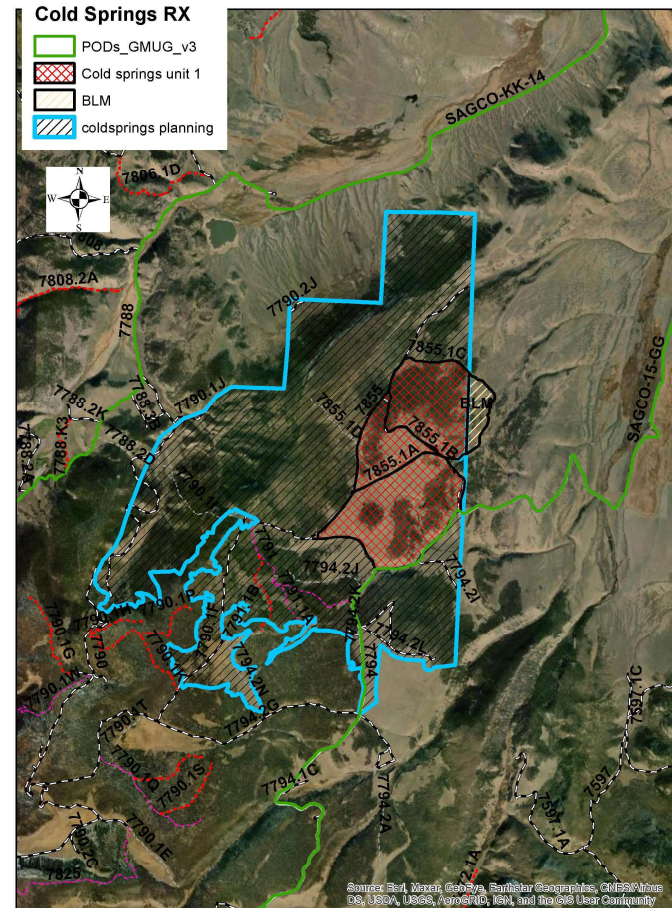

Cold Springs RX Plot 6

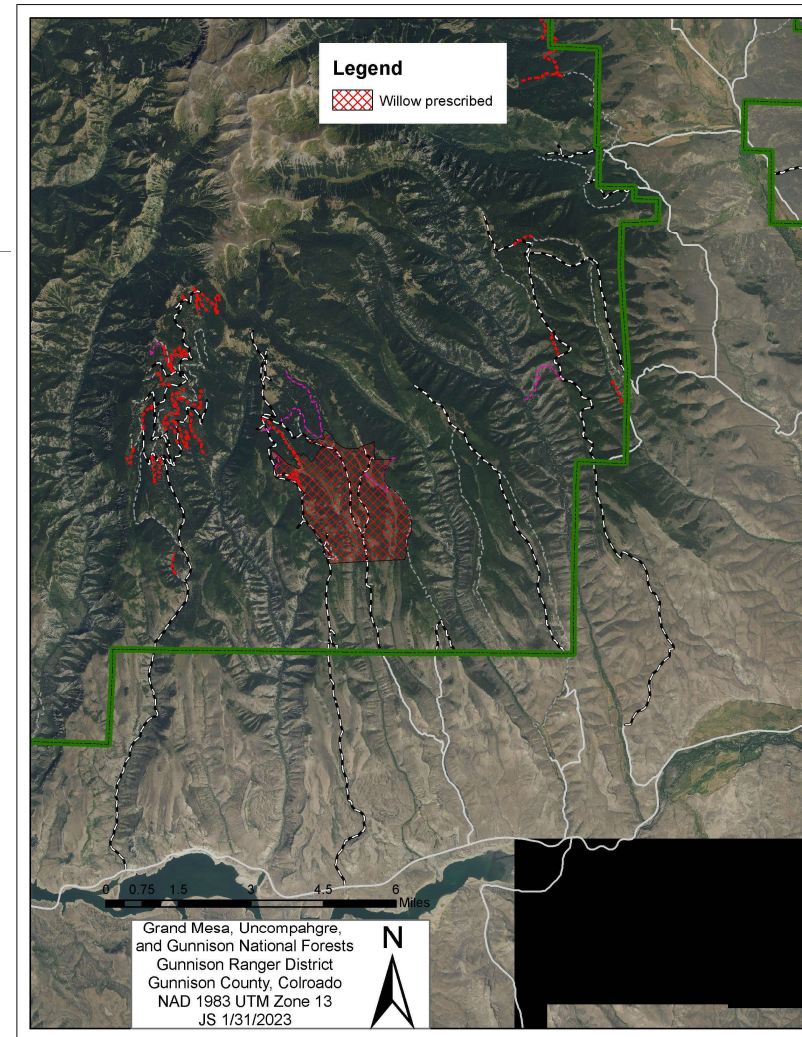
